He made reference to a bomb thereby placing the occupants of the aircraft in a state of fear and alarm and, separately, of a contravention of Article 63, ANO 2000, by failing to sit in his seat with his seat belt fastened, standing in the aisle, opening overhead lockers all during the approach to and landing of the aircraft.
